**Eligibility criteria**

**Eligibility criteria (description)**

Article 14

- (1) Agricultural holdings registered and agricultural cooperatives registered under the Law on Agricultural Holdings have the right to use the funds according to this law.
- (2) The users should have settled all financial obligations determined in Article 14a paragraph (2) of this law.
- (3) users who have outstanding and overdue financial obligations determined in Article 14-a paragraph (2) of this law, should settle them under conditions and written in Article 14-a of this law.
- (4) Beneficiaries from paragraph (1) of this article must keep all documentation and evidentiary material for the operation for five years from the year in which the financial assistance was used.
