**Eligibility criteria (description)**

Beneficiaries are agricultural holdings and/or purchasers registered in the Register of purchasers of agricultural products who have produced processing of primary agricultural organic products or products in transition of domestic origin or have carried out processing and packaging of wild species of organic origin and have sold them. . Users are also agricultural holdings - producers of organic cow, sheep and goat milk registered as breeders of cattle, sheep and goats, including users who produce food with traditional characteristics, and in facilities that are in the process of registration according to traditional production methods , cheese obtained from the milk of sheep and goats/dairies.
